Installation

Install the program by double clicking on HW Diary.prc. Once installed on the handheld, run HW Diary to complete the handheld based installation.

Registration

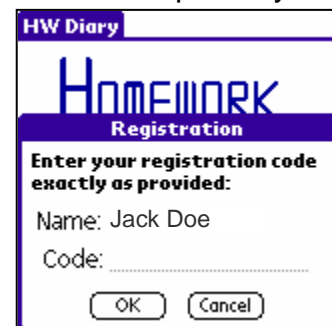
The unregistered version is fully functional for 15 days. After this time period you must register to continue to use the program.

Register HW Diary by:

On the trial screen tap the "Register" button and then enter in your registration code exactly as given.

On the main screen using the "Options" menu, tap "Register", and then enter in your registration code exactly as given.



Beaming a Demo Version

To beam a demo version of HW Diary to another handheld:

Tap "Beam HW Diary" then, tap "Beam PDATAdvUtilsLib", and finally, tap "Beam PDATPELib". This will beam the HW Diary application and the two libraries needed to run it.

(Note: HW Diary will NOT work without the two libraries.)

Help

To access help on the "Info" menu tap, "Help". The help section will provide help for each section of the program.

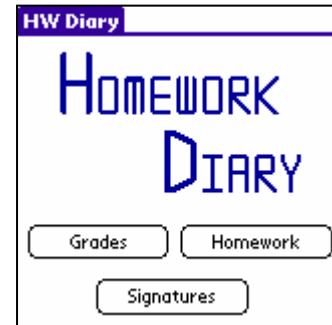
Main Screen

To view grades, tap the "Grades" button.

To view homework, tap the "Homework" button.

To view and edit signatures, tap the "Signatures" button.

To edit the password to the Grades part of program, tap "Password" on the "Options" menu.



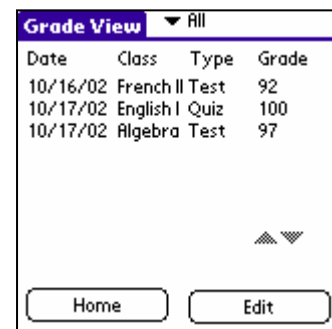
Grade View

To sort grades by class, tap the arrow towards the top of the screen.

To go to a specific grade in the "Grade Editor", tap on the grade in the list

To edit or view grades in more detail, tap "Edit".

To return to the main screen, tap "Home".



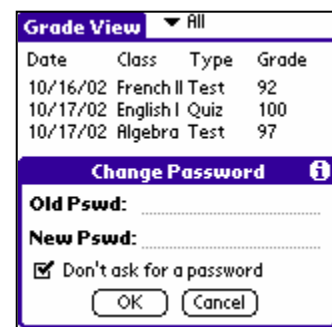
Password

To make changes to your password in the grade view, tap "Options" and then "Password".

The first time you edit the password it will be empty. To use a password uncheck "Don't ask for password", leave the "Old Pswd:" field, and write your password in the "New Pswd:" field.

The next time you change your password enter your old password in the "Old Pswd:" field and your new password in the "New Pswd:" field.

Make sure you do not have the "Don't ask for password" check box checked or you will not be prompted for a password.

If you do not want a password, enter your old password and check the "Don't ask for password" checkbox.

Passwords are limited to 20 characters.

Remember your password because there is not a recovery if you forget it.

Grade Editor

To select a class for the grade, tap the arrow that is next to the word "Class:".

If no classes are entered, tap "Edit" to edit classes.

To select a grade type for the grade, tap the arrow that is next to the word "Type:".

If no grade types are entered, tap "Edit" to edit grade types.

To choose a date, tap next to the word "Date:" and then choose a date using the on screen calendar.

To enter a grade write in the field next to the word "Grade:".

To enter a description write in the field under the word "Description:".

(Note: When the amount of text becomes larger than the description field a scroll bar will appear. It can be used to scroll through the text in the field.)

To add a grade, tap "New".


To go to a previous grade, tap "<".

To go to the next grade, tap ">".

To delete a grade, tap "Delete".

To beam a grade, tap "Beam".

To return to the "Grade View", tap "Done".

To enter a class name write in the field next to the word "Class:".


To add a class, tap "New"

To enter a grade-type enter text in the field next to the word "Type:".


To add a grade type, tap "New"

To return to the "Grade Editor", tap "Done".




Homework View

To sort homework assignments by class, tap the arrow in the upper right corner of the screen and then select a class to sort by. To view all classes select "All".

To go to a specific homework assignment in the "Homework Editor", tap on the assignment in the list.

To edit or view assignments in more detail, tap "Edit".

To return to the main screen, tap "Home".

Homework Editor

To select a class for the assignment, tap the arrow that is next to the word "Class:".

(If no classes are entered, tap "Edit" to enter or edit classes.)

To choose a date, tap next to the word "Due:" and then choose a date using the on-screen calendar.

To enter a description tap under the word "Description:" and then enter text.

(Note: When the amount of text becomes larger than the description area a scroll bar will appear. It can be used to scroll through the text in the field.)

To add a homework assignment, tap "New"


To go to a previous homework assignment, tap "<".

To go to the next homework assignment, tap ">".

To delete a homework assignment, tap "Delete".

To beam a homework assignment, tap "Beam".

To return to the "Homework View", tap "Done".

To enter a class name write in the field next to the word "Class:".


To add a class, tap "New".

Signatures

To choose a date, tap next to the word "Date:" and then choose a date using the on screen calendar.

To write your signature write in the box labeled "Parent Signature".

(Note: To use a bigger ink size make the shift stroke. To write in an even bigger size make the shift lock stroke. To use the eraser make a punctuation shift stroke.)

To write a teacher comment write in the field under "Teacher Comment:".

To write a parent comment write in the field under "Parent Comment:".

To add a signature, tap "New".

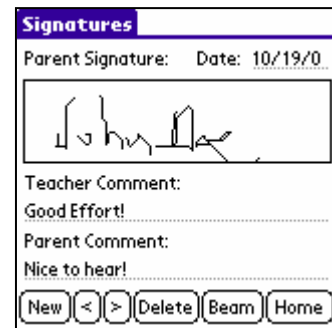
To go to a previous signature, tap "<".

To go to the next signature, tap ">".

To delete a signature, tap "Delete".

To beam a signature, tap "Beam".

To return to the main screen, tap "Home".

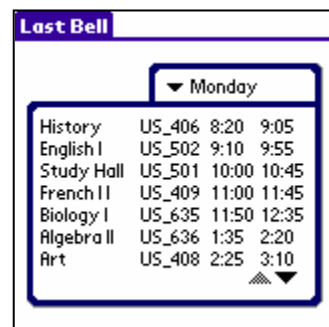


Last Bell
